NEW BUSINESS:

FLOCK Camera Presentation:

A representative for the FLOCK camera system came before the Mayor and Council to explain the FLOCK camera system and to answer any questions that the Mayor and Council had regarding the system. The city has received a quote for 10 "Falcon" devices, which is an infrastructure free license plate reader camera, and 1 "Raven", which is an audio detection device that provides law enforcement real time alerting of audio events such as a gunfire. The Raven covers a ¼ mile area. The contract is a two-year contract, with the first year being \$48,500.00 and the second year being \$42,000. This is a total of \$90,500. If after the two-year contract is up the city can decide if it wants to continue using the FLOCK system. If they choose to continue using the system, it is \$42,000 per year. If they choose not to extend the contract the company will remove the system, as they own the cameras.

The Mayor and Council thanked the FLOCK representative and said they would discuss this further after the first of the year.

Resolution to add membership in a fund of GIRMA:

City Clerk Vicki Wainwright informed the Mayor and Council that it is now mandated for the city to provide PTSD insurance for public safety employees. In order to do this the city needs to adopt the resolution as presented. A motion to adopt the resolution was made by Councilperson Jacob Hopkins and seconded by Councilperson Deborah Williams. The vote was unanimously approved. (Mayor Pro-Tem Ed Guinn was absent)

2nd and Final Reading: Tattoo and Body Piercing Establishment Ordinance:

The final reading of the proposed Tattoo and body piercing establishment was held during this council meeting. Councilperson Jacob Hopkins asked if the purpose of this ordinance was just to be proactive, or if there was an establishment interested in setting up in Butler. It was noted that this is this being proactive, so that the city has an ordinance in place should the need arise.

Attorney Jack Nichols stated that a question came up during the last meeting regarding neon signs, and he suggested revising the zoning ordinance to cover neon signs and/or distasteful signage. He also stated that an amendment to the zoning ordinance needs to be made to only allow an tattoo establishment in general commercial areas as a "conditional use".

A motion to adopt the tattoo and body art ordinance was made by Councilperson Jacob Hopkins and seconded by Councilperson Glenn Harris. The vote was unanimously approved. (*Mayor Pro-Tem Ed Guinn was absent*)

DEPARTMENT HEAD REPORTS

Public Works Director David Windham informed the Mayor and Council of the new Lead Service Line Replacement Project that has been mandated for all water systems. The EPA has come up with new compliance for lead and copper contamination and requires all water systems to have a service line inventory that indicates service line location and material for both the public side and private side. All water systems will be required to submit annual updates to their service line inventory to Georgia EPD until all service lines have been classified as non-lead. Letters will be sent out to all customers by November 15th as "unknown" service line material.

Mr. Windham invited everyone to attend the annual Christmas Tree Lighting on Monday, December 2nd at 6:30 at the Courthouse Square.

He said that trash pickup for the week of Thanksgiving will fall on Saturday, November 30th instead of Friday, November 29th.

He said that the water line improvement project in the Brown/Marshall area has the water main and service lines in, and service should be switched over within the next two weeks.

The bid opening for the sidewalk project will be Thursday, December 5th at 2:00 PM.

The deadline for the public to purchase personalized brick pavers in memory of or in honor of will be December 13th. He stated that the lamp post memorial plaques will be replaced and the names will be placed on brick pavers, which will be clustered in one area.
